A: We don't have those statistics. My suggestion for anyone on a limited budget is to take advantage of the variouis study groups. The \$ costs to participate in those groups is minimal. I would also suggest that

A: Ultimately you are judged on your ability to meet the standards detailed in Genealogy Standards (Nashville, Tenn.: Ancestry, 2014). We added the new requirement because it is clear that applicants who participate in development activities have a higher pass rate. Many people apply before they have the developed the skills needed to submit a successful application. There are many educational opportunities available to help you develop the skills that you need. You might review Standards 82 and 83 and read "Educational Preparation," Board for Certification of Genealogists (http://www.bcgcertification.org/certification/educ.html: accessed 4 October 2016). The May 2015 issue of OnBoard discusses the new requirement and includes a table that shows the genealogical education of recent applicants. As noted when this requirement change was introduced, asking applicants to describe their development activities is not necessary for evaluation purposes. If an applicant's attention to development is adequate, it will be
