A: I recoginize it. IT's Adobe Photoshop Elements.

Q: What are all the check marks that appear next to the images in the media file in Legacy. Do you need to keep the check marks there?

A: In the Media Gallery, a check mark means that photo has been tagged.

Audience Question:

Q: Why do you save as picture instead of document?

A: An attached photo can be included in a chart or report. An attached document cannot be included in a chart or report. An attached document can only be view from the MEdia Gallery.

Audience Question:

Q: What about migrating files on the same computer from the old Legacy default location to the new My Documents location?

A: Use the Media Relinker and Media Gatherer to move pictures.

Audience Question:

Q: What if you want to print that census in a book? It's 72dpi

A: Edit the census image in a picture editor to set the resolution to 200 or 300 dpi.

Audience Question:

Q: 1) no paste option in gallery

A: Make sure that you have the 8.0.0.454 update.

Audience Question:

Q: I'm already having trouble finding the Media Gallery in my Legacy database, so I hope you cover how to get to it.
A: In Favimy View or in the person's Individual Information screen, the Media Gallery button has two heads. When you mouseover it the popup tooltip will say Media Gallery.

Audience Question:

Q: Sometimes you are not given a choice about whether you want a jpg or pdf such as state governments. Can photoshop elements change a pdf to a jpg?

A: YES!

Q: Most newer cameras take pictures that are 12 to 16 megapixels or more. These can create rather large files.Is there an optimal resolution for pictures to be used in Legacy for reports, etc. Does the resolution of photos used make no difference, or does Legacy resize them for its own needs?

A: No, you can crop and rotate pictures, but you cannot change resolution in Legacy. Legacy picture editing features are very basic.
